NEW PENSION IMPROVEMENTS CAN MAKE

EARN MORE CREDIT TOWARD RETIREMENT

Did you know that your Pension Fund provides you with a **Defined Benefit Pension Plan? A defined benefit pension is a rare thing these days. It is the most secure form of a retirement plan—one where you are guaranteed (if you are fully vested)** a fixed monthly benefit amount based on the pension credits you earn and your employer's contributions to the Fund on your behalf.

Now, you can earn even more pension credits toward your retirement with two new provisions that the Trustees are pleased to announce.

Your hours equal more credits

Starting January 1, 2024, through December 31, 2028, you can earn up to two pension credits per calendar year when you work more than 1,499 hours in covered employment.

With the new Bonus Future Service Credit provision in effect, you'll continue to earn one pension credit for hours worked up to 1,200 hours. And now, for every 300 hours you work above 1,200 hours in that year, you'll accrue **bonus** pension credits at a rate of one-quarter (1/4) credit. You may earn a lifetime maximum of 10 bonus pension credits.

This chart shows how **Bonus Future Service Credits** will accrue starting January 1, 2024:

1,200-1,499 Hours Worked in a Calendar Year = One Year of Future Service Credit

Hours After 1,499 Worked in a Calendar Year	Total Hours Worked in a Calendar Year	Bonus Future Service Credit	Total Future Service Credit
1–300	1,500-1,799	1/4	11/4
301-600	1,800-2,099	1/2	1½
601-900	2,100-2,399	3/4	13/4
901+	2,400 +	1	2

What about the Hour Bank?

Now that you can directly accrue more than one pension credit a year with the Bonus Future Service Credit provision in effect, there is less of a need for the Hour Bank.

As a result, you must work more than 2,400 hours in a calendar year to add to your Hour Bank from January 1, 2024, through December 31, 2028. The maximum number of hours you can have in your Hour Bank remains 600 hours.

Your pension benefit can now grow further

Beginning January 1, 2024, there is no longer a limit to the number of pension credits you can earn. You are now able to accrue more than 40 credits throughout your covered employment.

What does this mean? With the removal of the pension cap, you continue to earn additional pension credits and grow your monthly benefit, even if you exceed 40 pension credits over your career.

Keep in mind, however, that Bonus Future Service Credits cannot be used for eligibility and that you can only earn up to one Future Service Credit per year toward eligibility.
